Application Fee

If the property rents before your application is processed, the processing fee will be refunded, or you may transfer your application to another of our available properties. However, an approved application for one property may not necessarily be considered an approved application for another property. Please contact the appropriate property manager. If there are multiple applications on one property, the applications are processed in the order received.

Our general quidelines to qualify are that you have a legal and verifiable income of approximately three times the monthly rent, two recent years of favorable rental references (excluding renting from family members) or home ownership and a minimum of two lines of good credit established with a creditor for six months who reports to Trans Union. Negative references or collections may keep an application from being approved. An application will be declined if a bankruptcy has been discharged in fewer than two years (in some cases three years) previous to the application being submitted.

Please contact the property manager for detailed information regarding specific qualifications, co-signers, pet approval, etc. If pets are allowed, an additional minimum deposit of \$300.00 will be required for each pet. If you own a large dog, you must show proof of Renter's Insurance. Most agreements begin with a one year lease. The security deposit and the first month's rent must be paid in the form of a cashier's check or money order prior to occupancy. Upon payment of a deposit, we will hold a vacancy for an approved application for up to 7 days.
